



Legislative Updates

For the past several years, CLC has been part of a national effort to institute a right to counsel for children and parents involved in the child welfare system. While this is already an established right in California, it is not consistent throughout the country and – as we know from firsthand



advocated for numerous forms of educational support, specialized therapies, and other ways to empower our clients and help them reach their full potential equine therapy is one form of

therapy that can be incredibly beneficial for youth.

Children who may shut down in traditional talk therapy often find new ways to open up and connect when around horses and other animals. Horses can be an incredible mirror for kids because horses often react to the emotions and behaviors of the people around them. In a nonjudgmental way, this reinforces for kids healthier ways to communicate, show respect, and express boundaries.

CLC staff have seen significant improvements for our clients participating in equine therapy, helping them find new ways to cope with their past trauma and interact more appropriately with caregivers and peers.

Equine therapy is typically not covered by health insurance and the cost associated with one week of treatment per client is approximately \$100. We are pleased to partner with the wonderful folks at Special Spirit Ranch to connect our clients with beautiful therapy horses and animals. The results have been astounding.
