Grants Update

CLC's successful grants program continues to grow! We are thrilled to announce that The Conrad N. Hilton Foundation has generously awarded \$3 million in funding to support and expand our Child Advocacy Resource Effort (CARE) Program for 3 years. This critical funding will allow CLC to provide the intensive CARE advocacy model to our clients who have been victims of commercial sex trafficking, in addition to dual jurisdiction and expectant and parenting (EPY) clients. CLC has also been awarded a generous grant from a private family foundation to support a new housing initiative to address the devastating impact the housing crisis has had on our older clients. The grant will fund a

Housing Navigation Specialist, two new housing-focused Peer Advocates and tangible support for rental assistance, down payments, and other essential housing-related needs. In addition, the In-N-Out Foundation has committed to continue supporting our Peer Advocates program in Northern California and educational assessments in Los Angeles. January is National Human Trafficking Prevention Month

January is National Human Trafficking Prevention Month. Since 2010, the President has dedicated the month to raising awareness about the different forms of human trafficking and educating people about this crime and how to spot it. Although awareness is growing every day, many still struggle to recognize that human trafficking—including the commercial sexual exploitation of children—doesn't just happen in other countries. It happens in every community throughout the United States.

According to the **National Foster Youth Institute**, it is estimated that 60 percent of child sex trafficking victims have a history in the child welfare system. Hence, CLC's dedicated multi-disciplinary advocacy approach focuses on providing intensive support to children who have experienced trafficking and pushing public policy changes to end the Commercial Sexual Exploitation of Children (CSEC).
