

Attorneys for children and youth – Monterey Park and Lancaster


CLC seeks passionate attorneys for our Monterey Park and Lancaster offices. CLC attorneys work closely with supervisors, social work investigators, various subject matter experts, peer advocates, support staff, and other CLC attorneys. In addition, attorneys provide clientdirected advocacy and legal advice to children, age 0-21, alleged to be victims of abuse and neglect.

CSEC (Commercial Sexual Exploitation of Children) Attorney

CLC is currently looking for a dynamic and motivated attorney to become the CSEC attorney for our Monterey Park office. Working at the intersection of child abuse and sexual abuse, our CSEC Team provides legal representation and intensive services to clients who have experienced commercial sex trafficking.

Directing Attorney – Prevention Program

CLC is seeking a dynamic manager and attorney to lead a new legal services program to prevent young families from entering the child welfare system. The program will serve young adults who are former foster youth/were previously involved with the child welfare system as children and are now parents at risk of their children entering the system.





CLC Client Spotlight: Meet April

CLC's Expectant and Parenting Youth (EPY) program provides intensive advocacy for our EPY both before and after their child is born. The program's goal is to surround our clients with the supportive services and resources they need to provide a safe and loving home for their young children. For expecting parents like April, the program's support was critical. 
intergenerational cycle of foster care.
